Recently summarized cases involve an unlicensed person who tried to collect a commission on the sale of a medical building, a website operator who contested accessibility requirements, and the dismissal of a RESPA class action effort.

White House Curbs Agency Guidance

The White House is curbing the ability of independent federal agencies like EPA and the Federal Reserve to issue non-binding guidance. Under the change, agencies are required to submit guidance to Congress for review if it's expected to have a major impact.

National greenhouse gas emissions have fallen 13 percent since 2005, EPA says. The trend shows industry is able to lower emissions without over-burdensome regulations, EPA Administrator Andrew Wheeler says.
